



Friendly-Frets In-Person Lesson Policy

Updated May 1st, 2023¹

2-Person Occupancy Limit:

No more than 2 people may occupy my lesson studio at one time. Parents and family members are welcome to sit in the entry way just outside of the studio in close proximity to their student.

Masks

Students/family members are not required to wear masks for in-person lessons.

If preferred, Students/family members are always welcome to wear masks during lessons and may request that I wear a mask during their lesson (masks will be readily available for students/family members upon request).

Students and family members must be willing to wear a mask when requested by myself, the instructor, on an as-needed-basis². This may be due to the following circumstances:

- Changes in guidance issued by WA State or Health Department.
- I request masking in order to manage health events for myself, household, or extended family.
- Students, Parents, family members have been exposed to covid or a virus from others in the past week.

Reporting Symptoms or Exposure to Covid/Virus

Please contact me to reschedule your lesson (or request to meet online) if you, or others in your household, have been exposed to someone who has tested positive for covid or someone who is sick with another virus within the past 48 hours.

Please contact me to reschedule your lesson (or request to meet online) if you, or members in your household, have experienced the following symptoms within 24 hours of your scheduled lesson³:

- **Fever or chills**
- **Cough**
- **Shortness of breath or difficulty breathing**
- **Fatigue**
- **Muscle or body aches**
- **Headache**
- **New loss of taste or smell**
- **Sore throat**
- **Congestion or runny nose**
- **Nausea or vomiting**
- **Diarrhea**

Additional Health Precautions

- I have been vaccinated for covid and will share my vaccination card upon request. I also update my flu vaccination on an annual basis.
- Hand sanitizer is available for students and families upon request.
- There will be times when I will opt to wear a mask during lessons.
- I will maintain safe distancing (3' - 6' feet) between myself and students/parents.
- Hand-sanitizer is available to students/parents upon entry.
- I run an air purifier in the studio at all times during lessons.
- I regularly clean all surfaces in the lesson studio.
- I will contact students/families to reschedule lessons if myself, or one of my family members becomes sick with covid related symptoms.
- Weather/Noise permitting: I may keep window(s) open for increased air-flow.

³I will waive my 24-hour cancellation fee listed in my general policy. Students may reschedule or receive credit for their missed lesson.
